Update on the November 4, 2025, Municipal Election

Christa Miller reported that there are currently 359,654 eligible voters for the Municipal Election, with 30,767 mail ballot requests, of which 17,754 are Democratic, 9,494 are Republican, and 3,519 are third party.

The Election and Voter Registration Office recently completed its Logic and Accuracy testing, which went very well, and will begin programming voting machines soon. The office is also in the middle of poll worker training, and Ms. Miller stated that they are in a good position at this point. She also reminded everyone that in-person mail ballots will begin being accepted at the counter starting Tuesday, October 14.

At Commissioner Yoder's request, Ms. Miller explained that voters will receive an email notification when their mail ballot is approved. Voters can also check the ballot tracker online to see whether their ballot has been received, is pending, or has been cancelled.

Ms. Miller also addressed the extended office hours prior to the election, stating that typically the office is open until 8:00 p.m. on the Friday before Election Day. However, since that Friday falls on Halloween, the office will instead be open on Thursday, October 30, until 8:00 p.m., and on Friday, October 31, until 6:00 p.m. In addition, the office will be open on Saturday, November 1, from 8:00 a.m. to 11:00 a.m., and on Election Day, Tuesday, November 4, from 7:00 a.m. to 8:00 p.m.

The Board expressed their appreciation to Christa Miller and her staff for their continued hard work and dedication.

On motion of Commissioner Parsons, seconded by Commissioner Yoder, the meeting adjourned at 11:14 a.m.
