AFFIDAVIT OF ACCOUNTABILITY OF SUPERVISOR

I am aware that circumstances have been alleged which may have prompted the requirement of supervised visitation. Those circumstances are:

I agree to be fully accountable to the Court as a supervisor in this matter. I hereby submit to the personal jurisdiction of the Court for this purpose.

I agree to abide by and fulfill the following requirements and conditions of the role of supervisor:

1. I will not, under any circumstances, allow the minor Child(ren) and _____ to be alone at any time.
2. I understand that the role of a supervisor requires my constant physical presence with the Child(ren) and _____.
3. I understand that I must accompany the minor Child(ren) and _____ on any and all excursions, no matter how short or long in duration, if such excursions are permissible in this case.
4. I will make prompt notations of any behavior of _____ which I believe to be harmful, or which reasonably could be harmful, to the best interest of the Child(ren) and I will make a prompt report of those observations to counsel for both parties and to the Court.
5. I will not permit _____ to drive a motor vehicle after having consumed alcoholic beverages or controlled substances, or while under the influence of

alcohol or controlled substances, with the Child(ren) present in the motor vehicle. At all times, I shall insure that the Children are securely fastened in an appropriate passenger restraint while traveling in a motor vehicle.

6. I will not permit _____ to operate dangerous machinery in the presence of the Children after having consumed alcoholic beverages or controlled substances, or while under the influence of alcohol or controlled substances.
7. SPECIAL CONDITIONS:

I am aware that I may be found in contempt of court if I do not comply with the requirements of a supervisor as set forth above.

I am aware that if I am found in contempt of court for failing to abide by the requirements of a supervisor, I may be fined or incarcerated, or both.

I understand that I cannot delegate my responsibility as a supervisor to anyone else without the prior approval of the Court.
