1. Filing shall mean and include docketing, entering, indexing and filing.
2. A counterclaim is not to be considered as commencing a new action.
3. Garnishment proceedings shall not be considered as part of the execution.
4. Proceedings on any lien other than revival shall be interpreted as commencement of new action.
5. Certification of any papers or giving of any memorandum of filing
6. Any action of proceeding to strike off, or open, any judgment shall be considered as commencement of action.

The Prothonotary shall not be required to enter on docket any suit or action or order of court or enter any judgment thereon or perform any services whatsoever for any person, political subdivision or the Commonwealth until the requisite fee is paid. - 42 P.S. § 21073 (b)
