

## Reservation and Booking Information

**PUBLIC/SERVICE GROUPS** are governmental, educational, religious, civic, service or bipartisan groups that do not charge a fee. If a fee is charged, it is nominal and covers only operating expenses. Public/service groups with a 501(c)3 may be eligible for a discount when renting certain facilities.

**PRIVATE GROUPS** are any groups that do not fit the Public/Service Group criteria listed above.

**NON-RESIDENT GROUPS** are groups whose primary business address is outside of Lancaster County.

**IN-PARK** programs are scheduled within the properties owned by the Lancaster County Department of Parks and Recreation.

**ON-SITE** programs are held at the requesting group's location.

- Facility reservations and program bookings are made on a first come, first served basis, up to 364 days in advance.
- Facility reservations, program bookings and pool memberships can be made over the phone or in-person at the Parks Main Office or the Environmental Education Office. Program registrations and pool memberships can be made on our website.
- Full payment for reservations and memberships is required at time of purchase. Payment for ball field rentals and special events will be made according to the terms and conditions for those activities.
- Groups making facility reservations or program bookings of 5 or more dates are eligible for a 15% discount if full payment is made in advance.
- Hard-surface courts and open field areas (excluding campgrounds, ball fields and open-air pavilions) are available on a first come, first served basis to the general public if no reservation has been made.
- All open-air facilities with water and restrooms are winterized (water service shut down) from October 15 to April 15.

## Refund Policy

Persons or groups reserving facilities or booking programs do so with the understanding and acceptance of the following:

- Cancellations made by the Parks Department are subject to a full refund.
- Customer cancellation or re-scheduling requests made **15 or more calendar days** before the event date shall have all fees returned, less a 10% processing charge per date booked.
- Customer cancellation or re-scheduling requests made **8 to 14 calendar days** before the event shall have 50% of their fees returned.
- Customer cancellation or re-scheduling requests made **7 or fewer calendar days** before the event date shall forfeit any refund.
- All refunds less than \$10 will be credited to the customer's account - no check or credit card refunds will be issued for amounts less than \$10.


## Rain Cancellations

Rain cancellations are defined as outdoor planned events (no roof overhead) which are rained out before the event begins. These may be refunded or rescheduled at no charge, subject to availability.


